



## Excess Automobile Liability Insurance

Excess Automobile Liability Insurance coverage provides registered volunteer drivers with additional protection for bodily injury or property damage claims arising out of their volunteer activities. This policy excludes property damage to property owned or transported by the registered volunteer driver, or in their care, custody or control. The liability policy is written at a combined single limit as respects bodily injury and property damage of \$500,000 each accident over and above any other applicable insurance. **This excess automobile liability policy comes into effect if you should have an accident while driving as part of your volunteer duties and your liability is greater than your own automobile insurance limits.**

You **MUST** carry your own automobile insurance if you will be driving yourself or any clients or other volunteers on Volunteer Initiative Program business.
