Note: Furlough obligations will be pro-rated for any employees hired after 7/1/10, have a change in their regularly scheduled hours in the payroll system, or who change bargaining units. The calculation will be based upon the remaining furlough obligation of the bargaining unit, the time remaining in the furlough period and the regularly scheduled hours of the employee in the payroll system.

**\*Correctional Officers Furlough:**

Employees on 5/8 schedule - Furlough will be from 6/26/10 - 6/24/11

Employees on 7/12 schedule - Furlough will be from 6/26/10 - 7/8/11

**\*\* Health Care Professionals Unit (Total 7.5% Furlough for Bargaining Unit)**

All employees will serve a mandatory 5.77% furlough. The remaining 1.73% obligation for the bargaining unit will be achieved through additional furlough commitments made on an individual voluntary basis, will vary employee by employee, but must equal 1.73% total for the bargaining unit.
