**SUBJECT: INSTALLATION OF FIVE RESIDENTIAL STREET LIGHTS WITHIN COUNTY SERVICE AREA NO. 9, ZONE "A," LITTLEWAY LANE**

Members of the Board:

The Department of Public Works has received a petition (see Attachment "A") from residents of Littleway Lane in the Watsonville area requesting the installation of five new standard street lights at the locations shown on Attachment "B." This area is already within the County's residential lighting district, Zone A, of County Service Area (CSA) No. 9; therefore the installation of new street lights will not affect service charges currently paid by property owners. The petition is signed by all residents or property owners in the immediate vicinity of the proposed light.

The Pacific Gas and Electric Company has advised us that the installation of five 70-watt, residential street lights is feasible on the existing poles. The installations will result in a charge of approximately \$10.75 per month per light on the County's street lighting bill. Sufficient funding for these new lights is available in the CSA No. 9A residential lighting budget.

It is therefore recommended that the Board of Supervisors authorize the installation of five 70-watt, standard residential street lights on Littleway Lane.

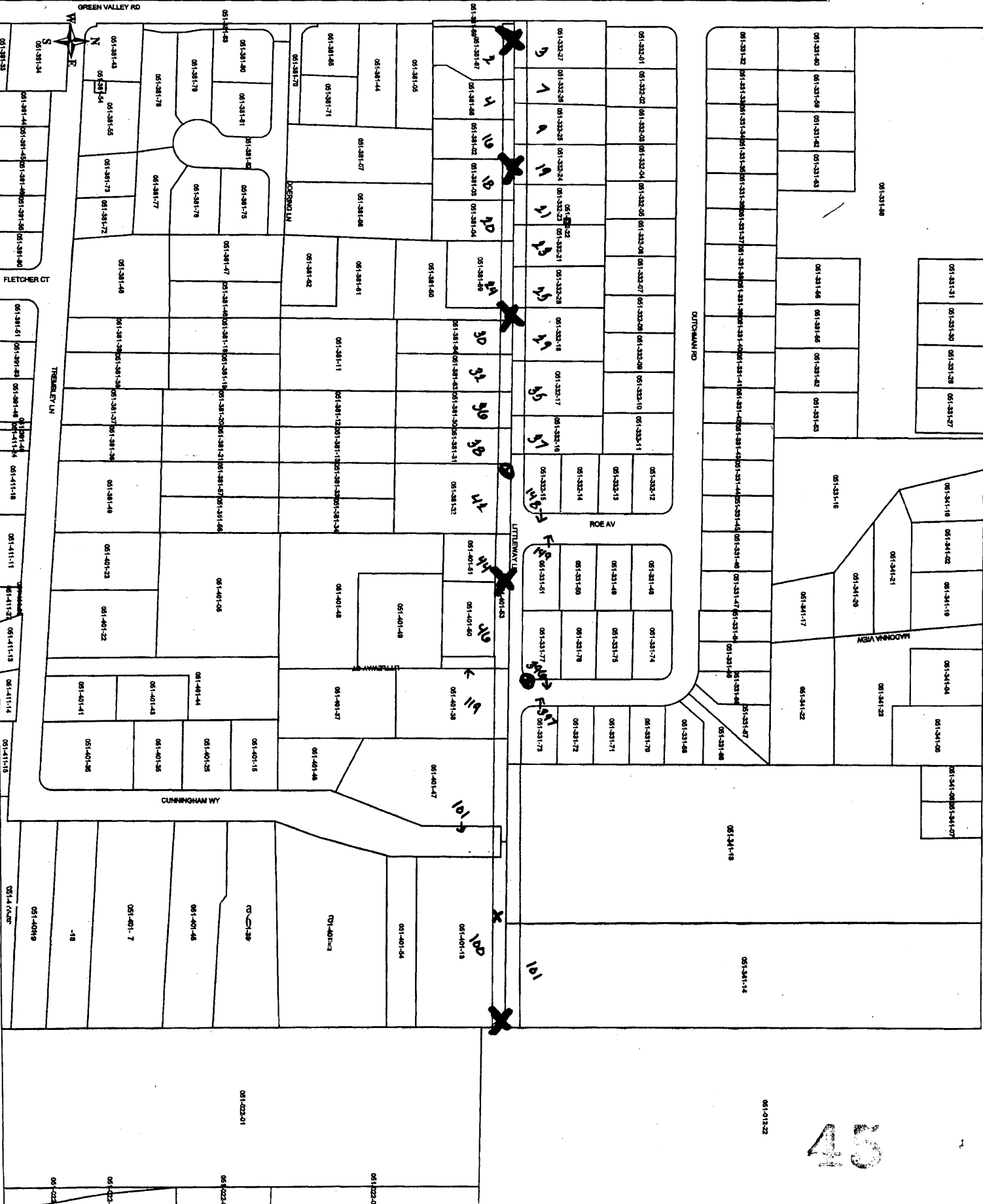
